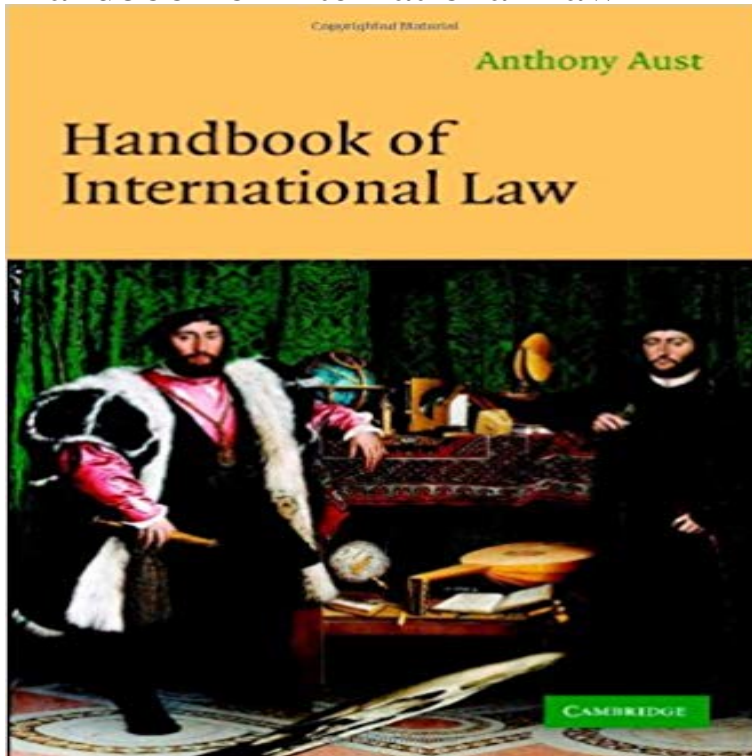


Handbook of International Law
