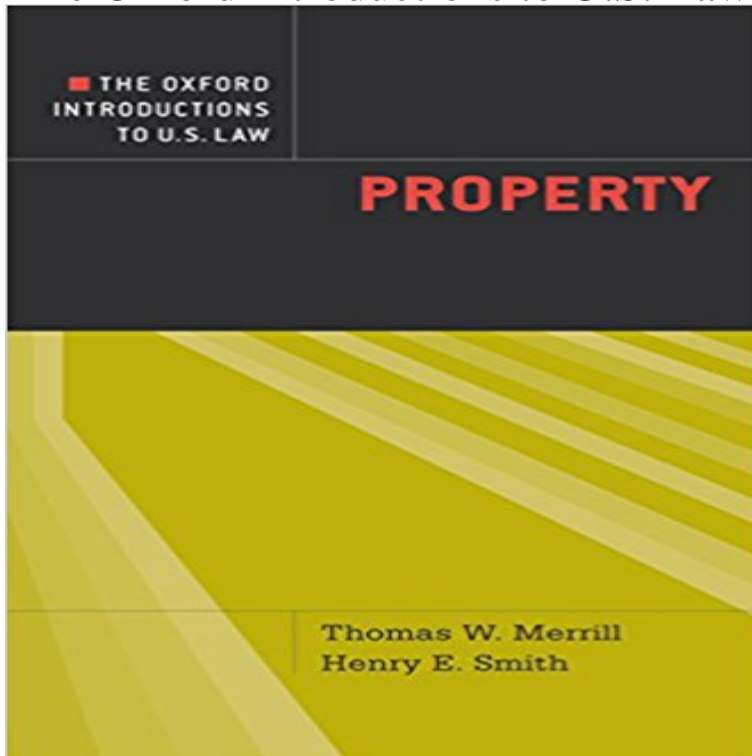


## The Oxford Introductions to U.S. Law: Property
