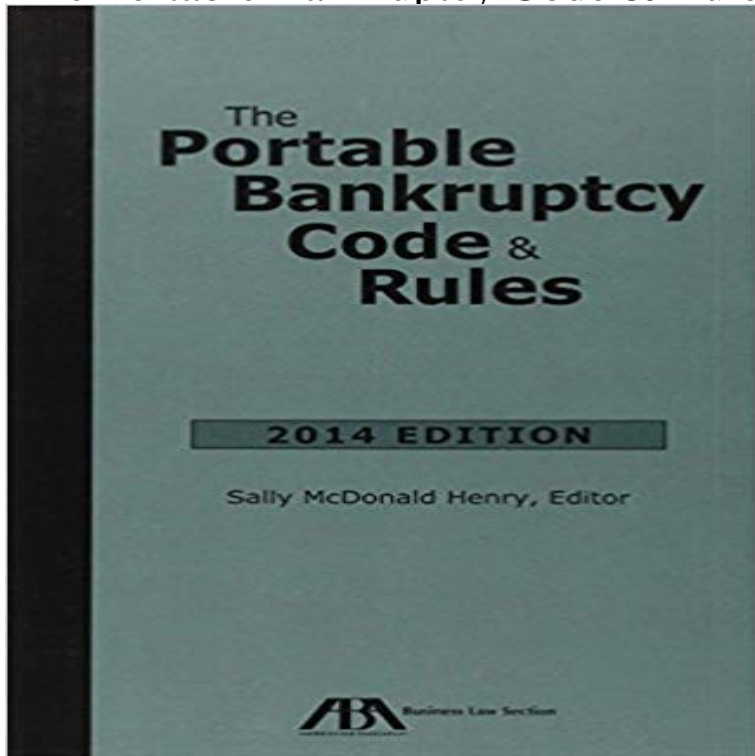


## The Portable Bankruptcy Code & Rules
