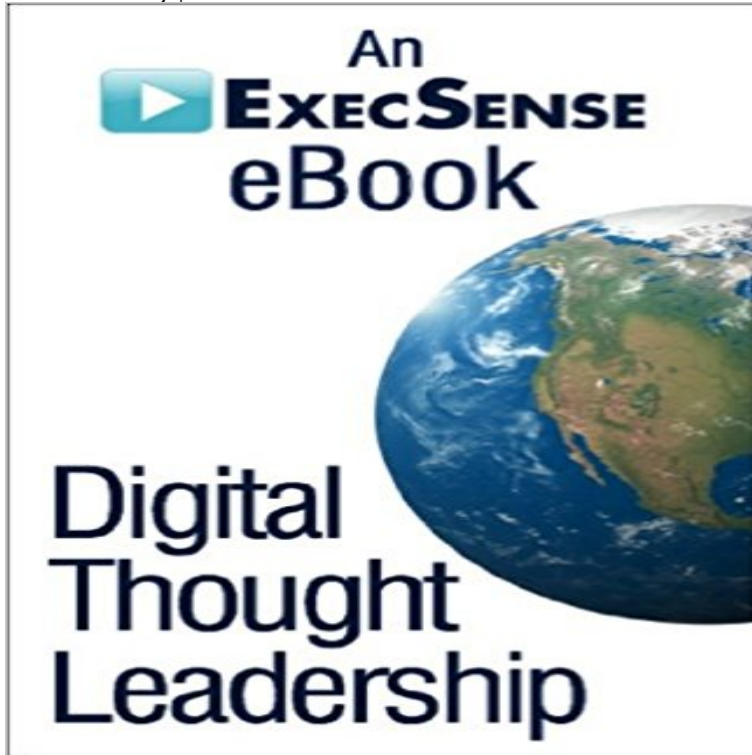


Positive Psychology and Family Business: Integrating Science and Planning



About the eBook I have had the privilege of working closely with family businesses across the United States for nearly thirty years. I also married into a family business and, so, had the opportunity to experience family business dynamics from the inside. While many of these family businesses have prospered, I have seen too many fail as a result of dysfunctional and unhealthy family relationships. Sometimes this conflict resulted in intra-family litigation, sometimes even in intra-family fistcuffs. Perhaps most often, simply and sadly, in irreparably breached relationships where family members wound up speaking to each other only indirectly through their legal counsel before severing their business and family relationships. My experience has not been unusual. The high statistical failure rate of family businesses is well known to professionals working in the field (approximately 9 out of 10 family businesses never make it to the 3rd generation), giving rise to the even better known related proverb shirt sleeves to shirt sleeves in three generations. While the proliferation of articles, books, and seminars on subjects like succession planning, estate planning, and wealth management planning attests to the commitment professional advisors have to serving their family business clients, the continuing inability of family businesses to successfully transition from generation to generation suggests that the traditional planning tools that have been used are inadequate for the tasks at hand. My studies and work over the years has led me to develop a new approach to working with family businesses and their team of professional advisors that is based on complimenting traditional plans and strategies by applying lessons and insights from science - particularly evolutionary biology and positive psychology. This article discusses why family businesses need to incorporate science into their
