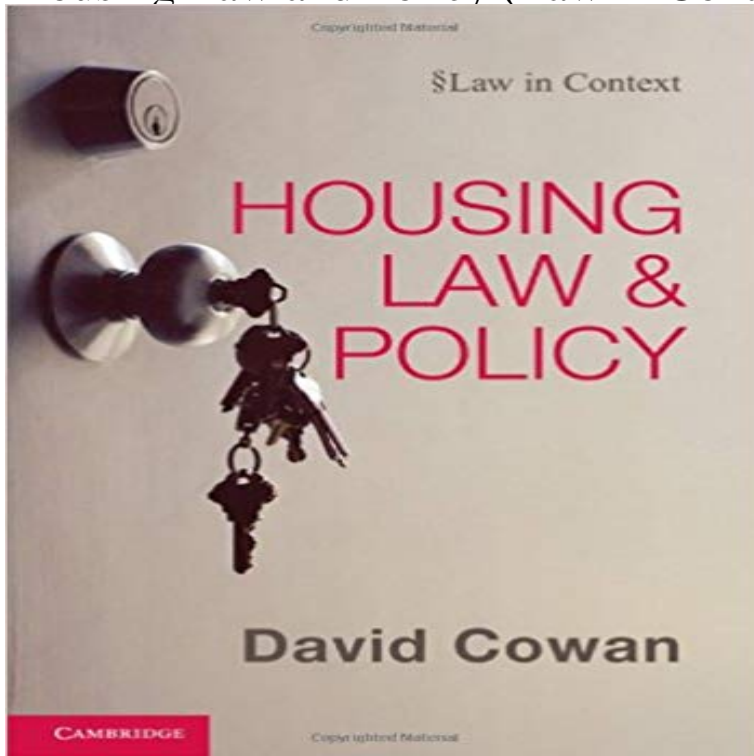


## Housing Law and Policy (Law in Context)
