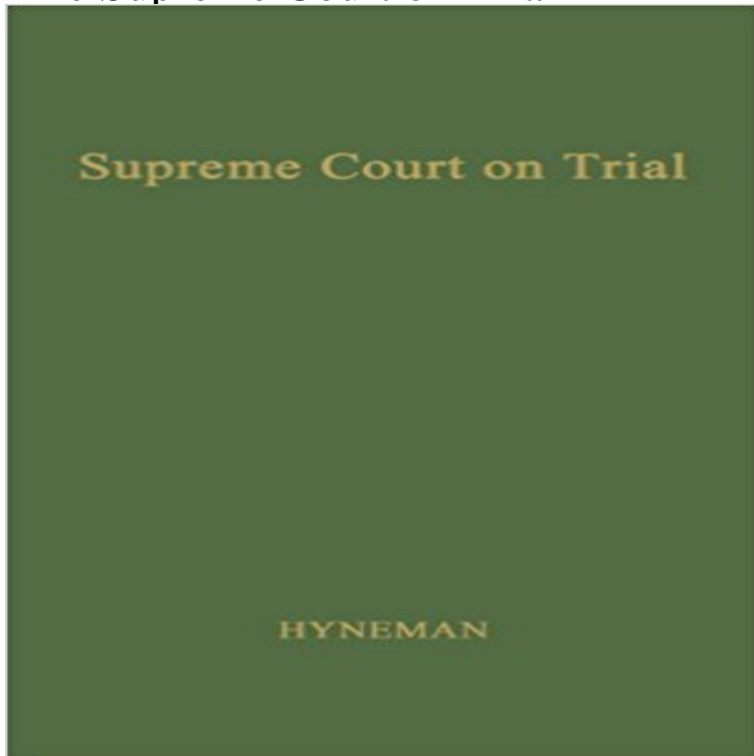


The Supreme Court on Trial
