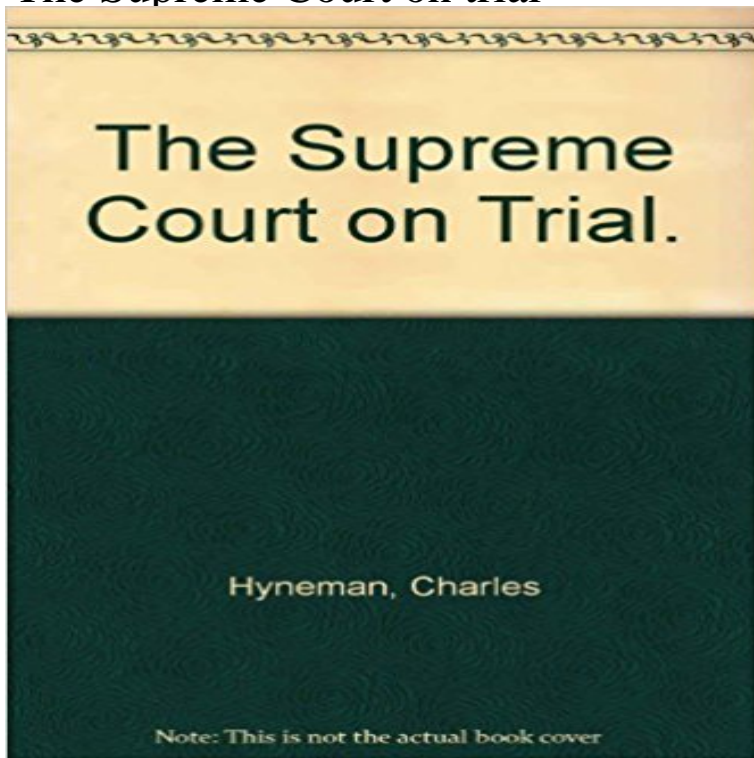


## The Supreme Court on trial
