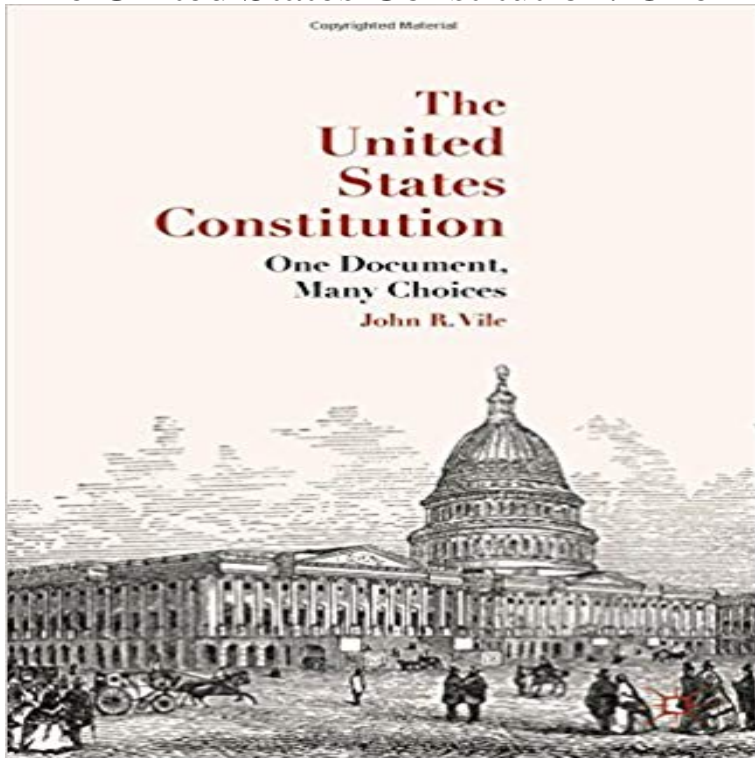


The United States Constitution: One Document, Many Choices
