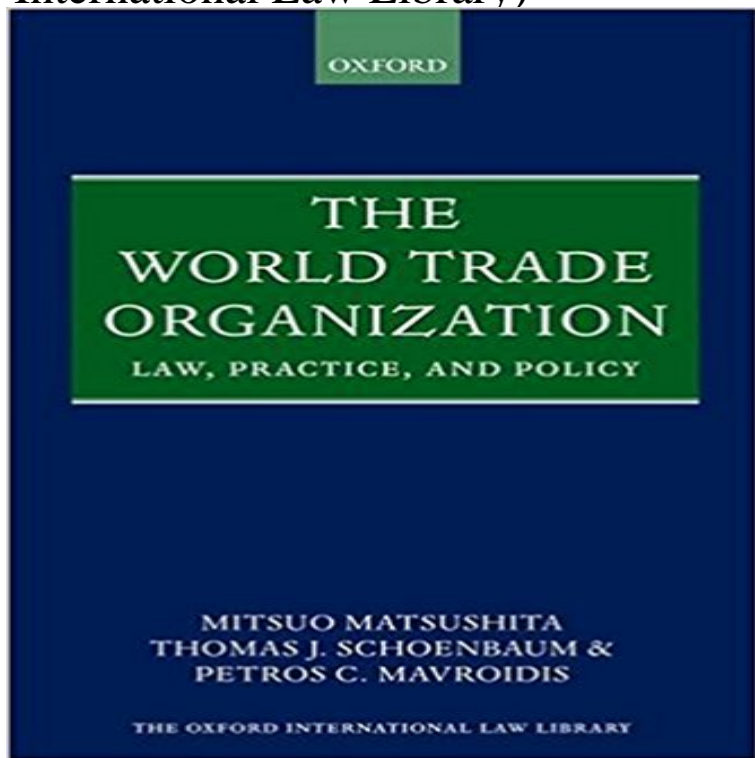


## The World Trade Organization: Law, Practice, and Policy (Oxford International Law Library)
