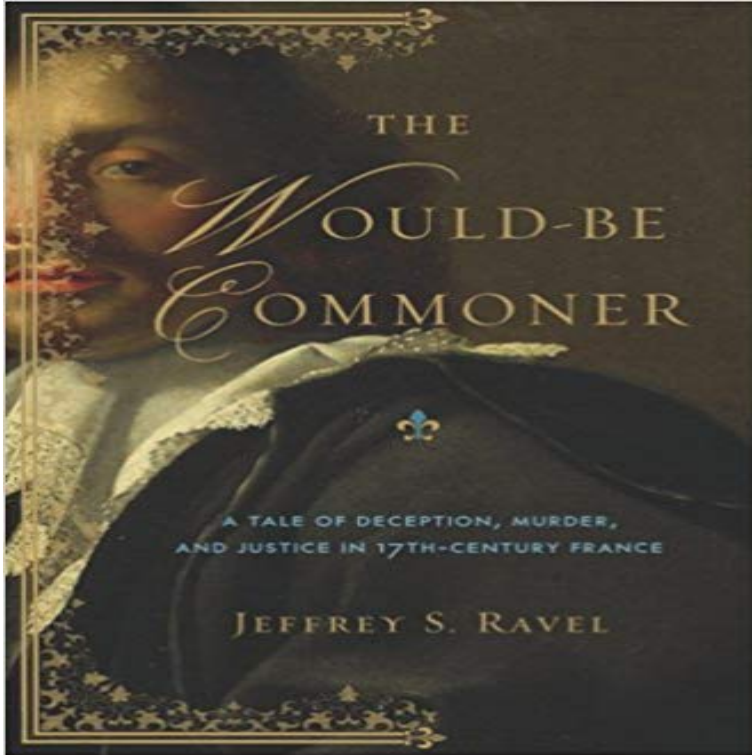


The Would-Be Commoner: A Tale of Deception, Murder, and Justice in Seventeenth-Century France

This led to a murder investigation and the arrest of Pivardicre's first wife and her alleged lover, a local prior. Stranger yet, Pivardicre finally did come out of hiding but was believed by many to be an impostor conjured up in order to clear the wife of murder charges. The case became a cause célèbre across France, an obsession among everyone from the peasantry to the courts, from the Comedie-Francaise to Louis XIV himself. It was finally left to a brilliant young jurist, Henri-Francois d'Aguesseau, to separate fact from fiction and set France on a path to a new and enlightened view of justice. Masterfully researched and vividly recounted, *The Would-Be Commoner* charts the monumental shift from passion to reason in the twilight years of the Sun King.
