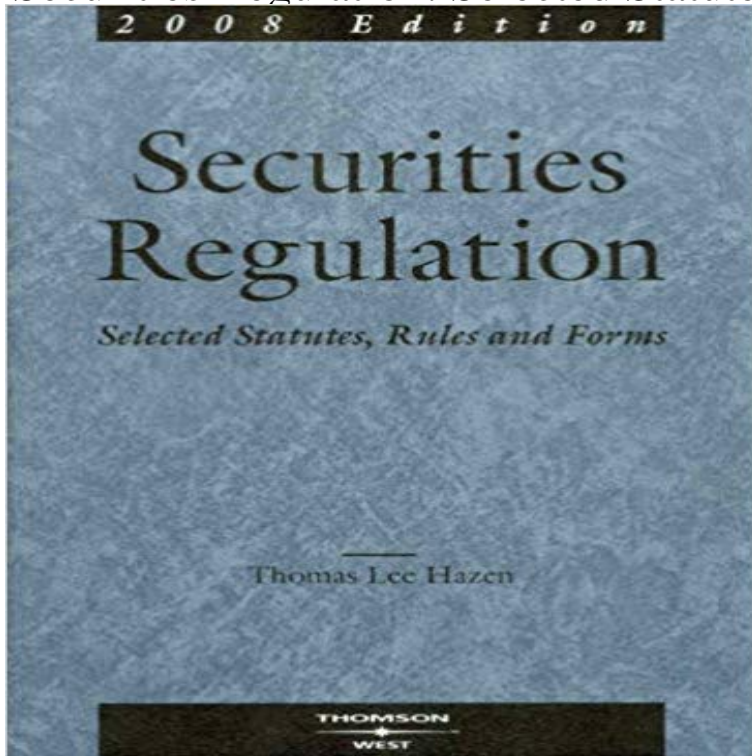


## Securities Regulation: Selected Statutes, Rules & Forms, 2008 ed.
