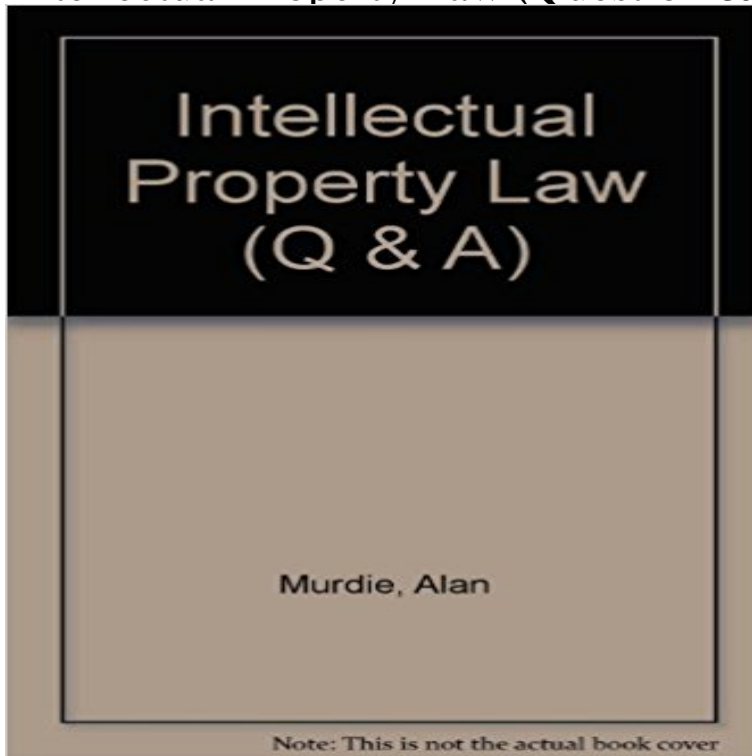


Intellectual Property Law (Question & Answers)
