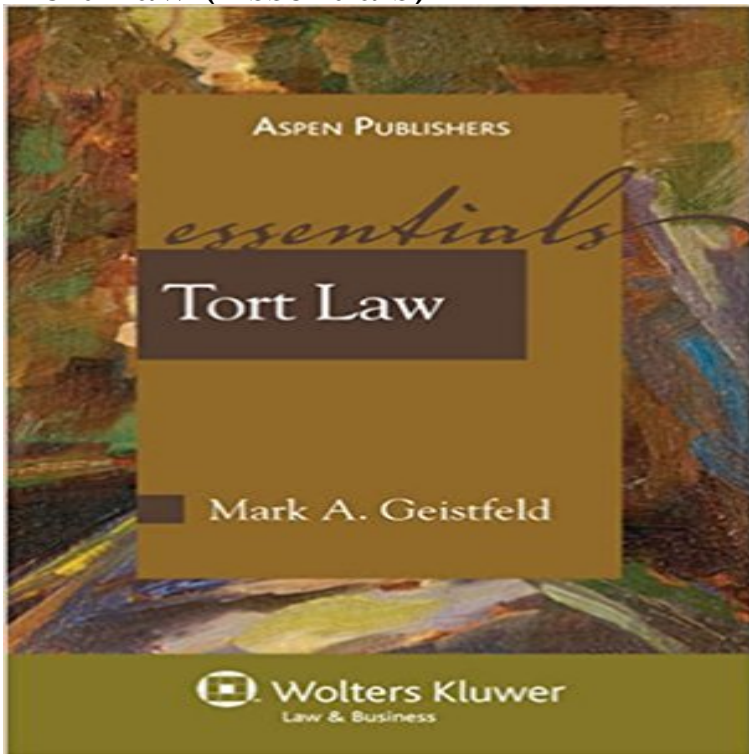


Tort Law (Essentials)
