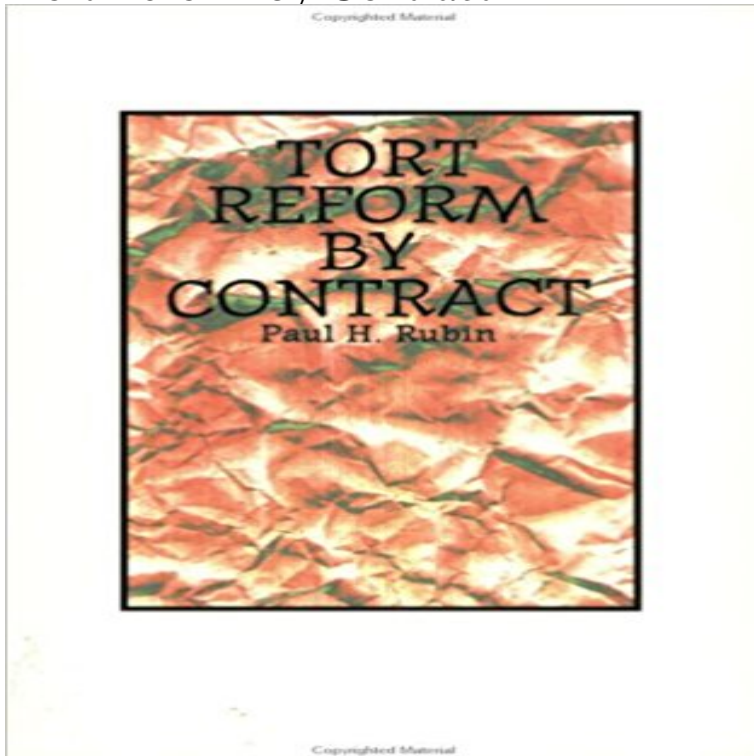


## Tort Reform by Contract
