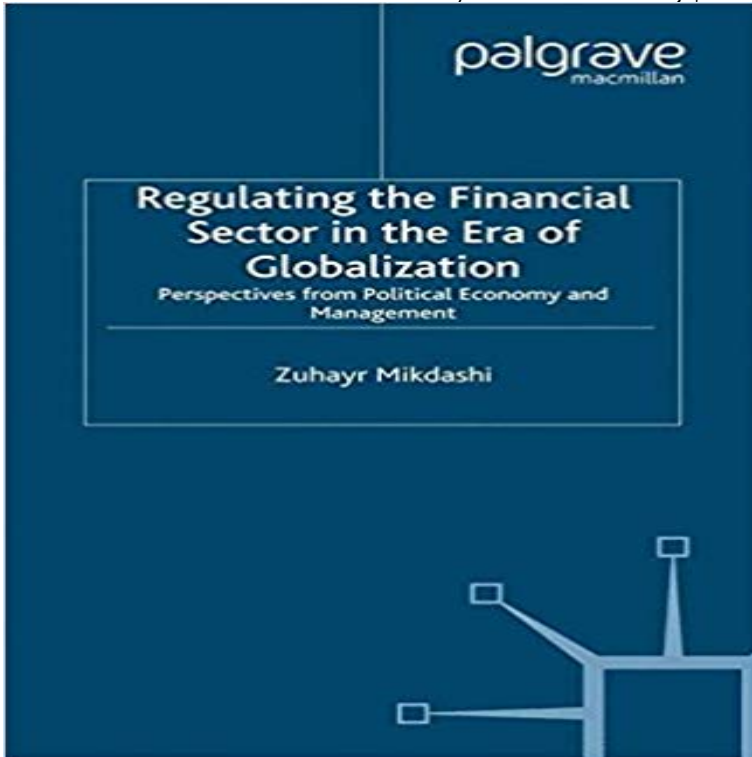


Regulating the Financial Sector in the Era of Globalization: Perspectives from Political Economy and Management
