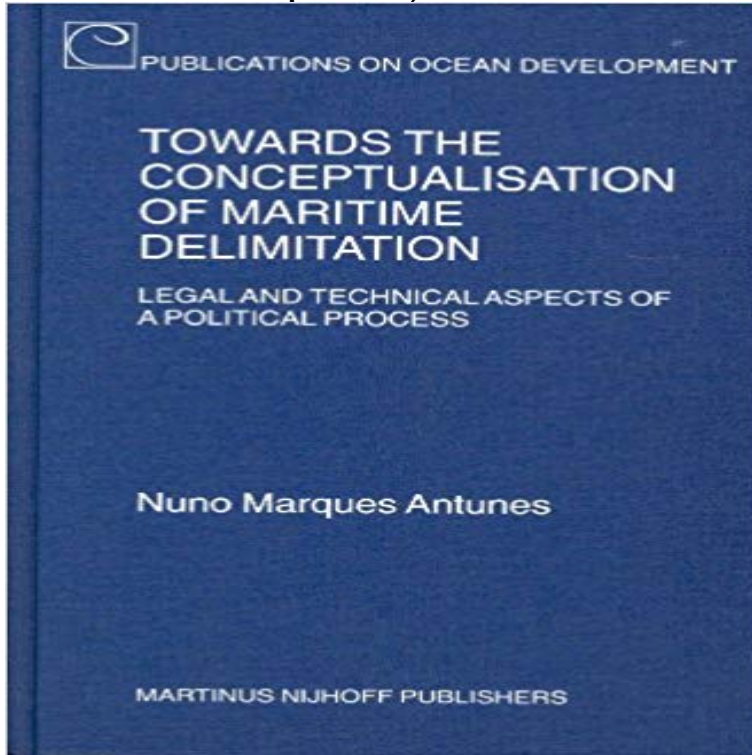


## Towards the Conceptualisation of Maritime Delimitation (Publications on Ocean Development)
