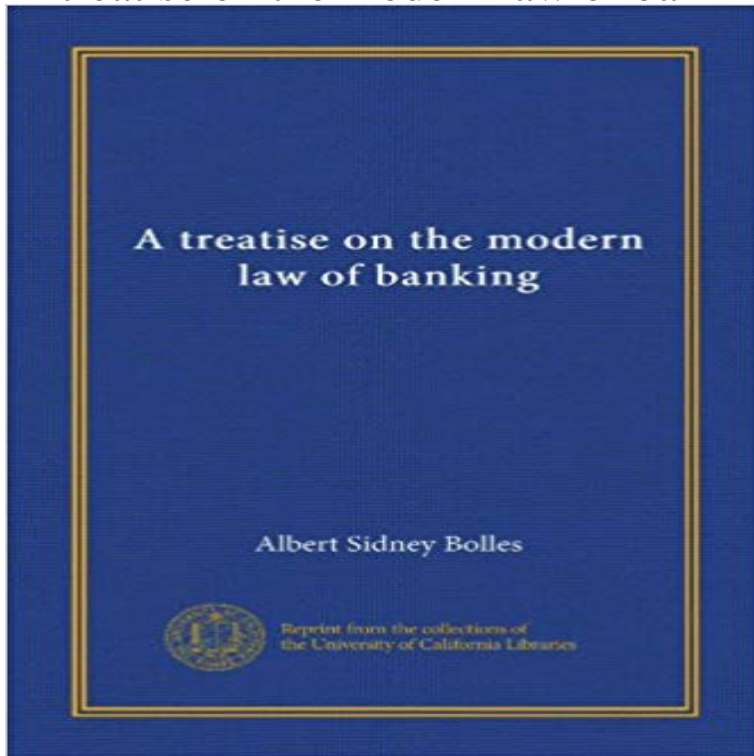


A treatise on the modern law of banking (v. 2)
