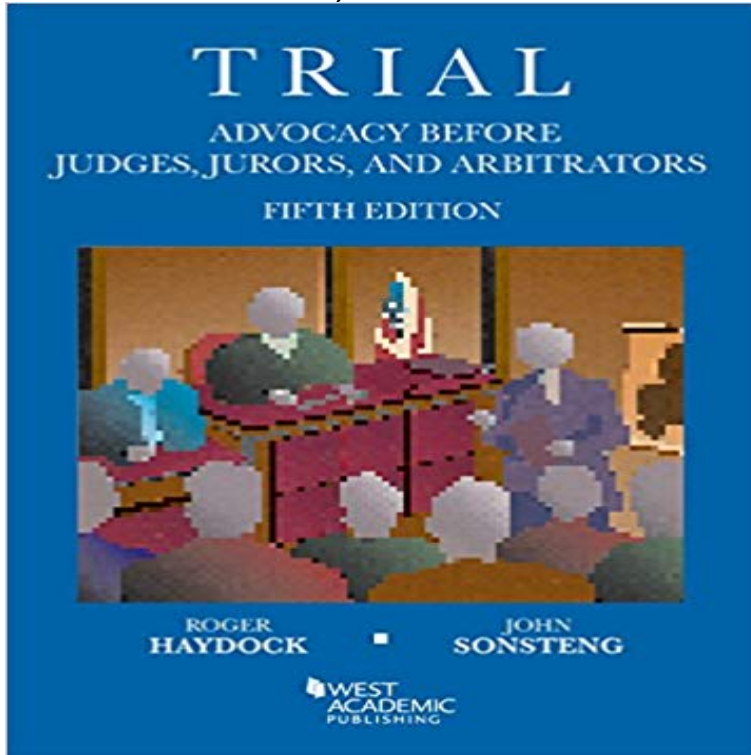


# Trial Advocacy Before Judges, Jurors, and Arbitrators (American Casebook Series)
