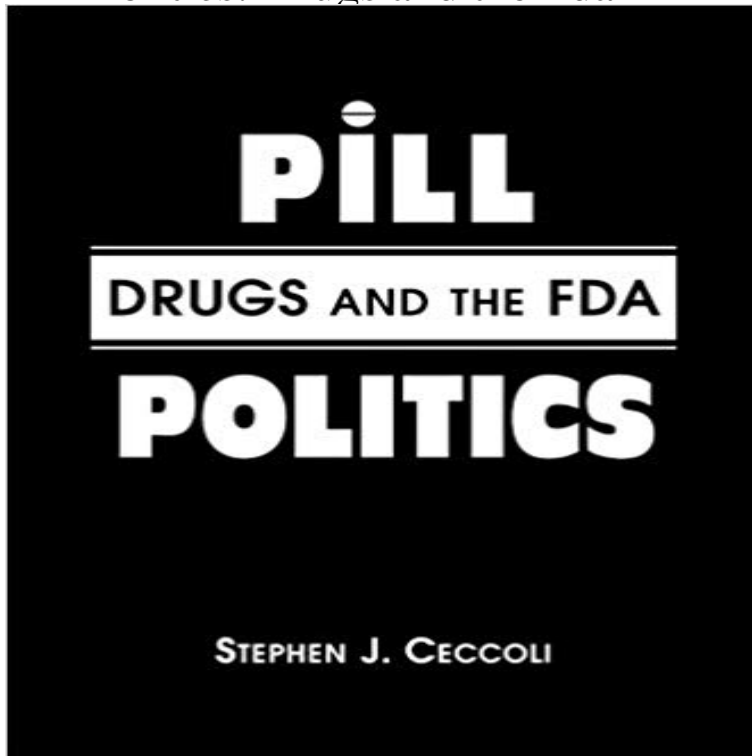


Pill Politics: Drugs and the Fda
