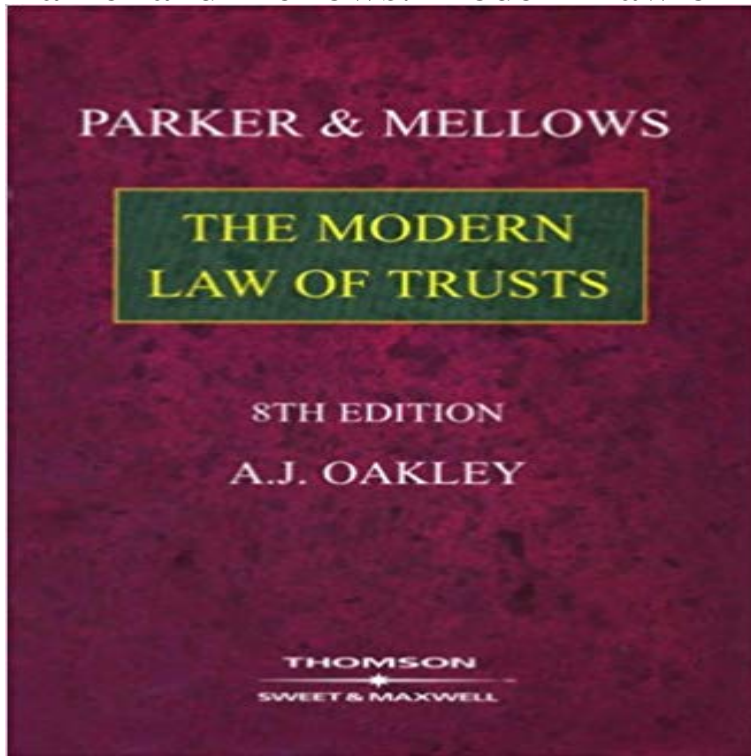


## Parker and Mellows: Modern Law of Trusts
