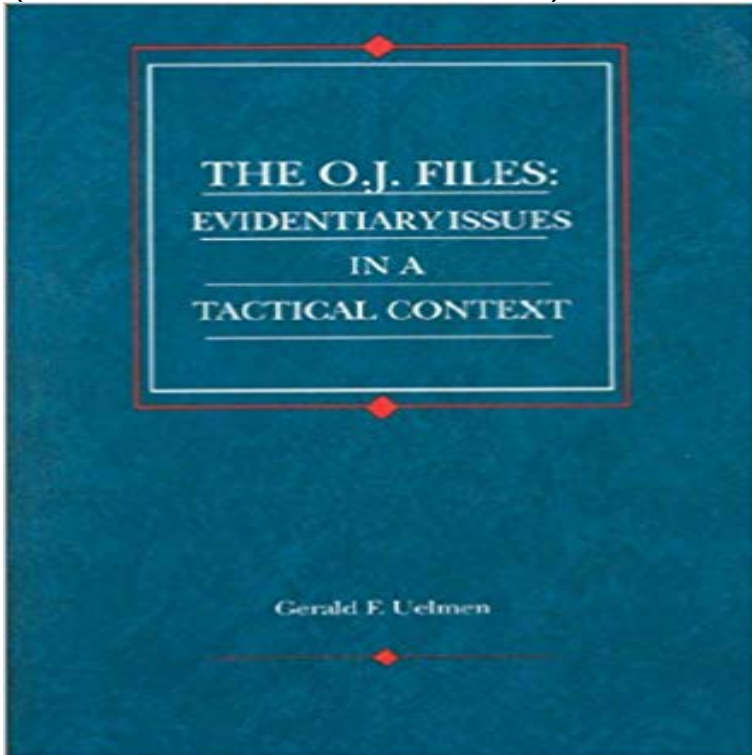


Uelmens The O.J. Files: Evidentiary Issues in a Tactical Context (American Casebook Series)
