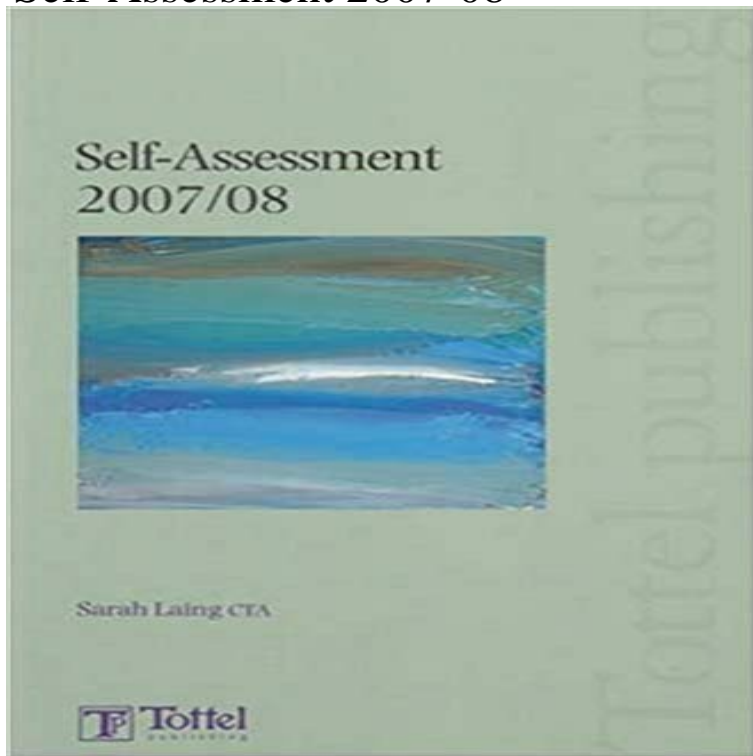


## Self-Assessment 2007-08
