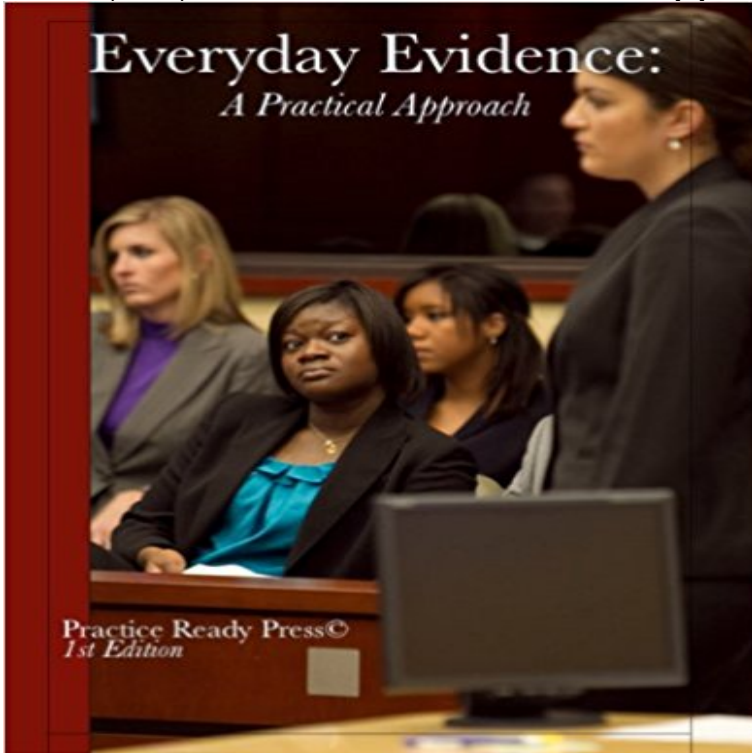


## Everyday Evidence: A Practical Approach
