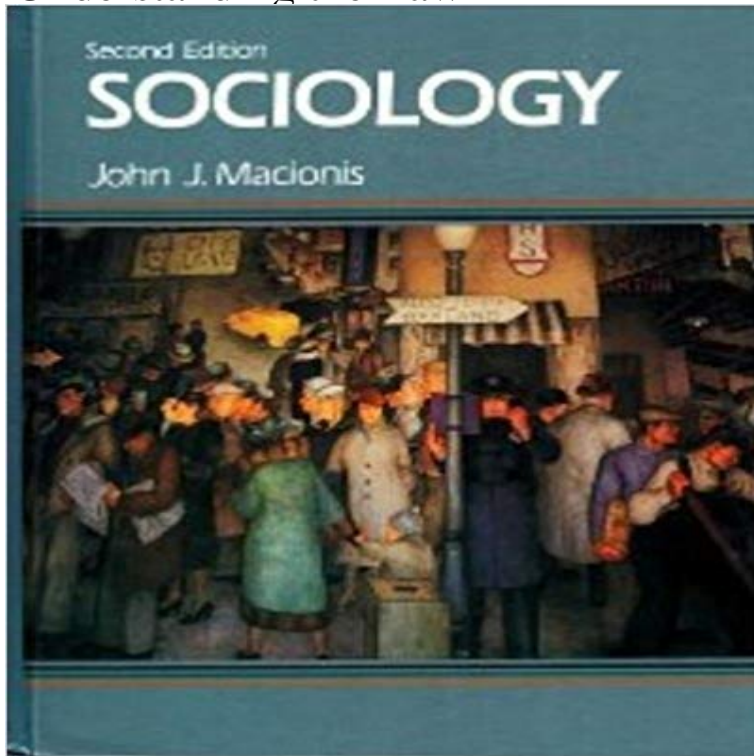


# Understanding the Law
