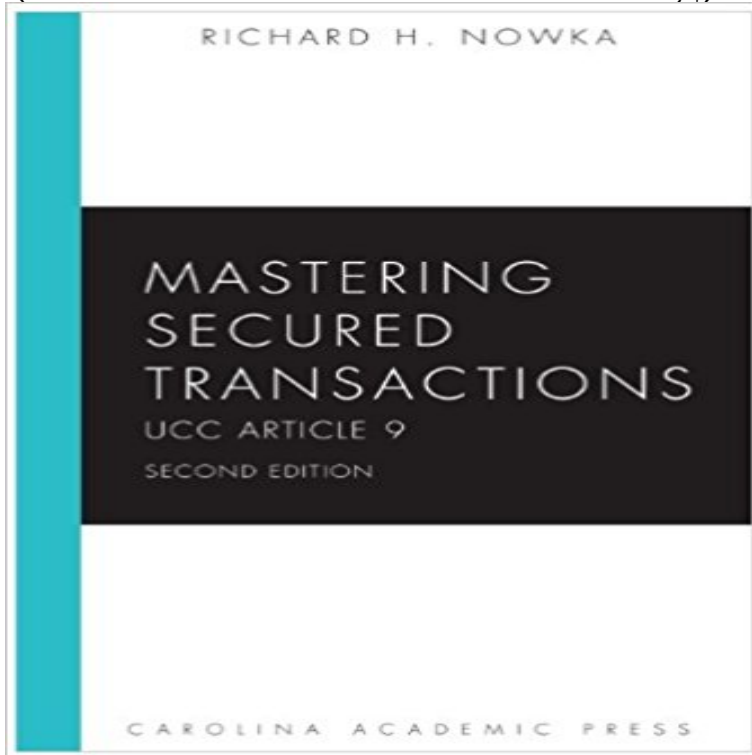


Mastering Secured Transactions (UCC Article 9), Second Edition (Carolina Academic Press Mastering)
