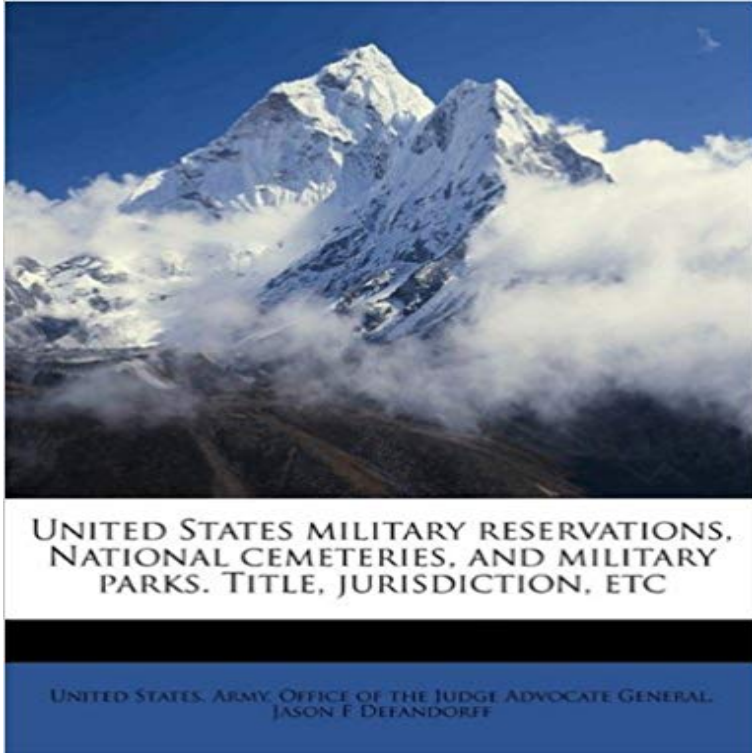


United States military reservations, National cemeteries, and military parks. Title, jurisdiction, etc
