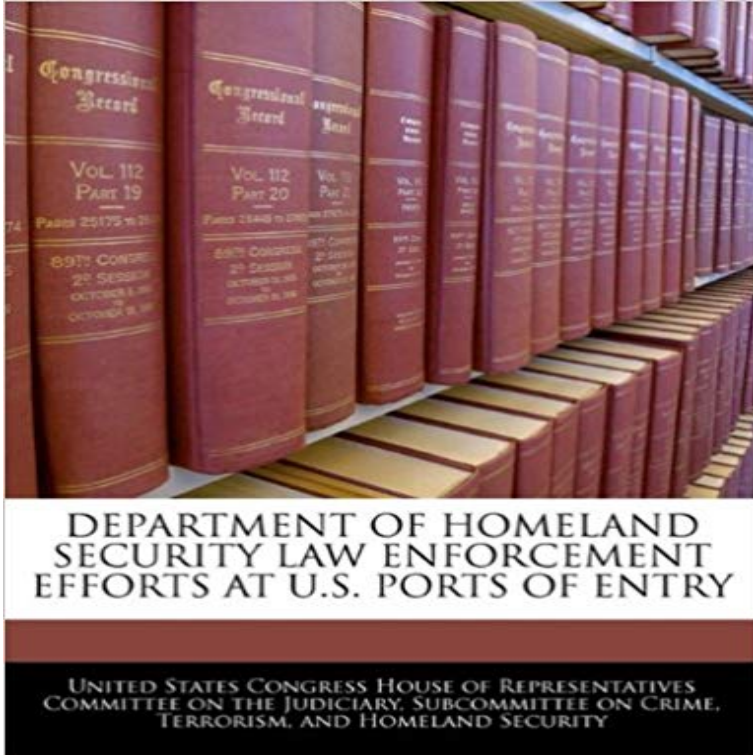


DEPARTMENT OF HOMELAND SECURITY LAW ENFORCEMENT EFFORTS AT U.S. PORTS OF ENTRY
