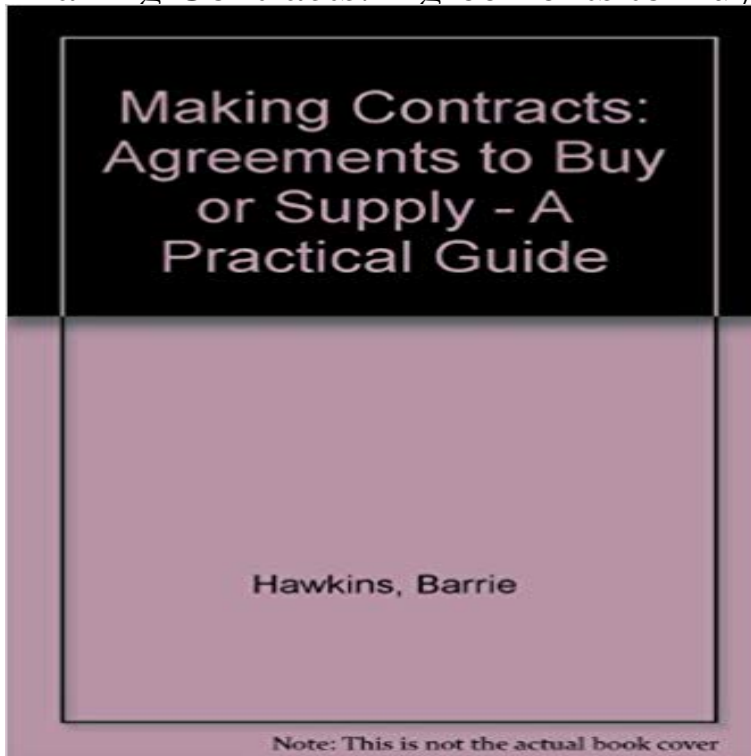


Making Contracts: Agreements to Buy or Supply - A Practical Guide
