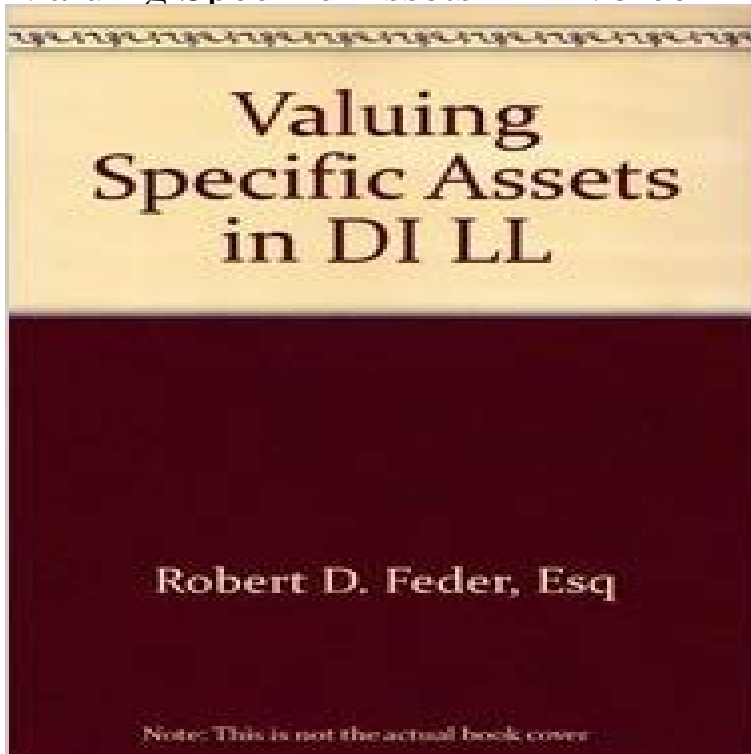


## Valuing Specific Assets in Divorce
