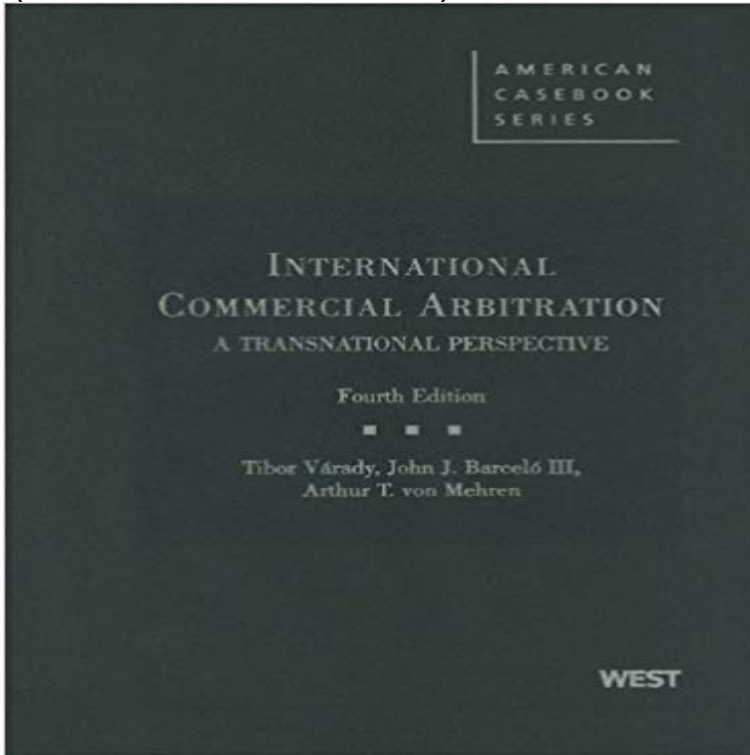


# International Commercial Arbitration: A Transnational Perspective (American Casebooks)
