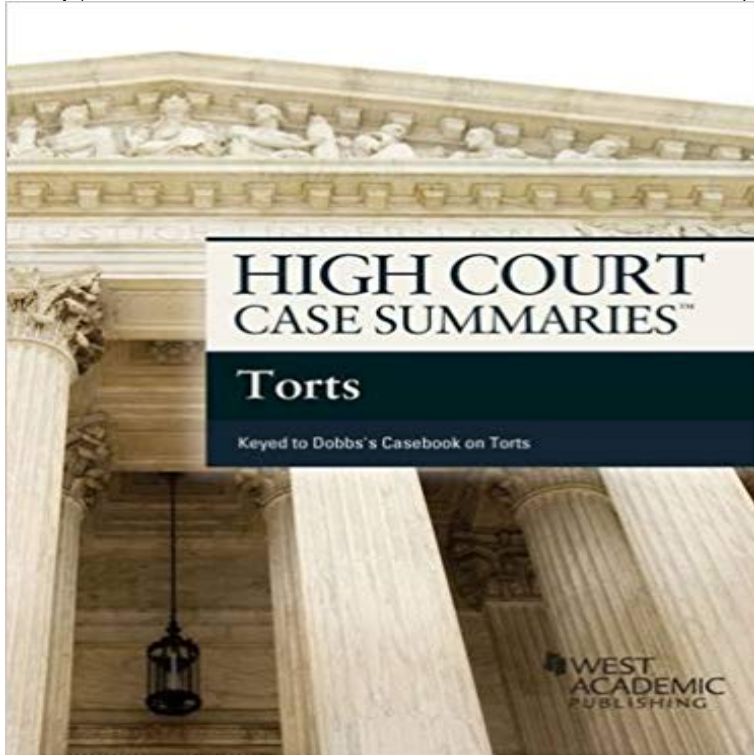


## High Court Case Summaries on Torts, Keyed to Dobbs,
