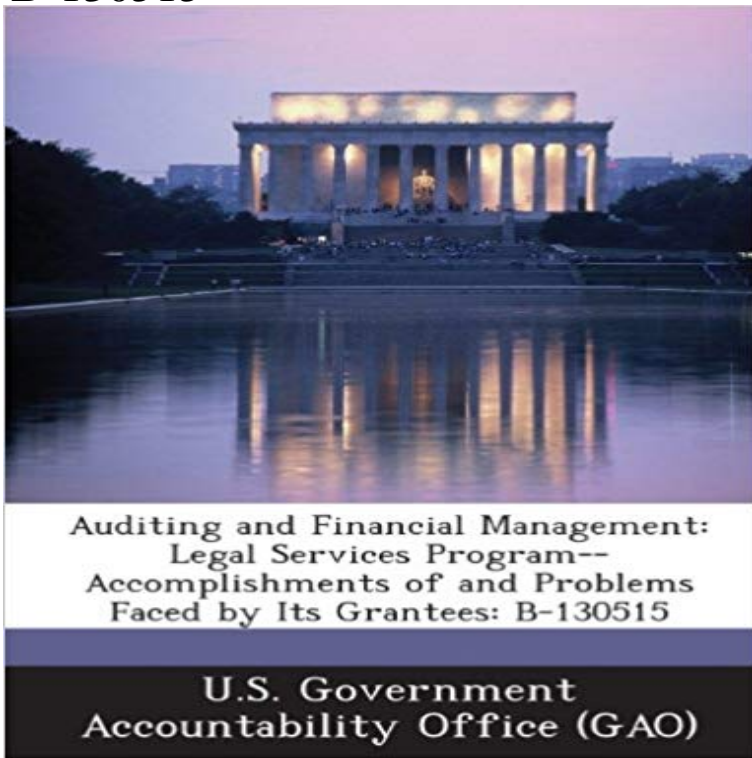


# Auditing and Financial Management: Legal Services Program--Accomplishments of and Problems Faced by Its Grantees: B-130515
