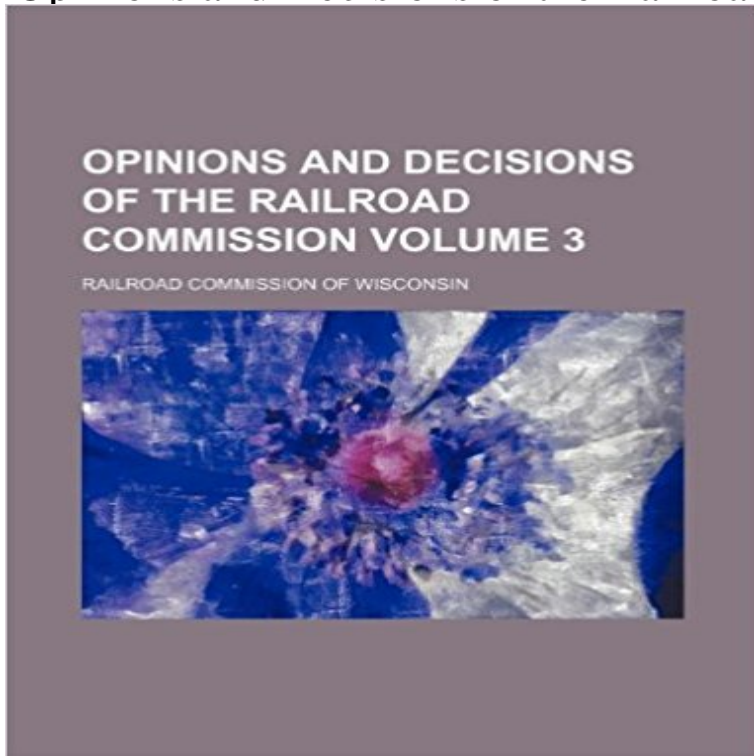


## Opinions and Decisions of the Railroad Commission Volume 3

It is said to be the policy of the company promptly to clear troubles wherever they occur, and it is reasonable to suppose that some inconvenience in carrying out that policy might be experienced if reliance were placed upon rented vehicles. Somewhat more than one-half of the subscribers are scattered through the country, and the clearing of trouble and the repairing of lines and substations often necessitates long drives. First class service at remunerative rates is probably cheaper in the long run, both to the company and to subscribers, than inferior service at rates correspondingly low.
