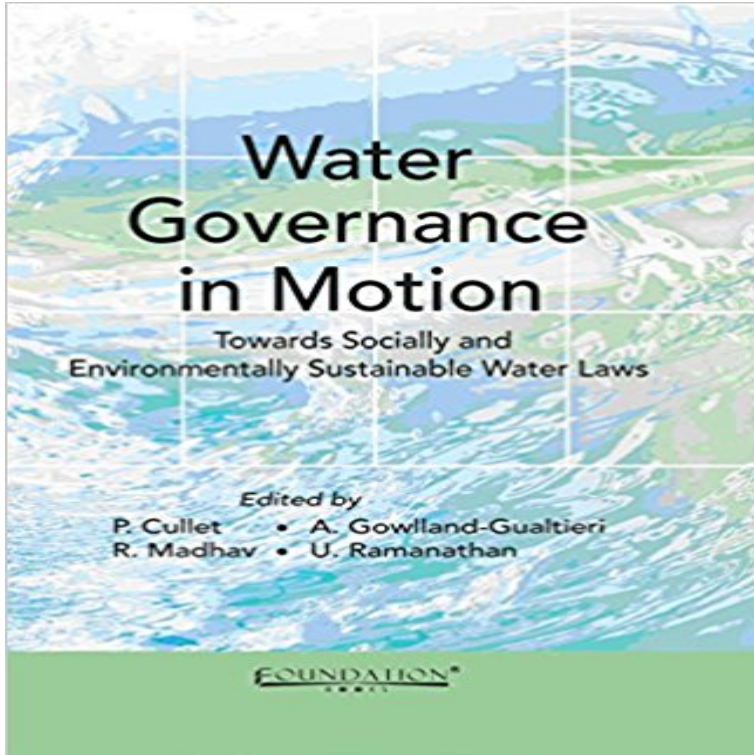


Water Governance in Motion: Towards Socially and Environmentally Sustainable Water Laws
