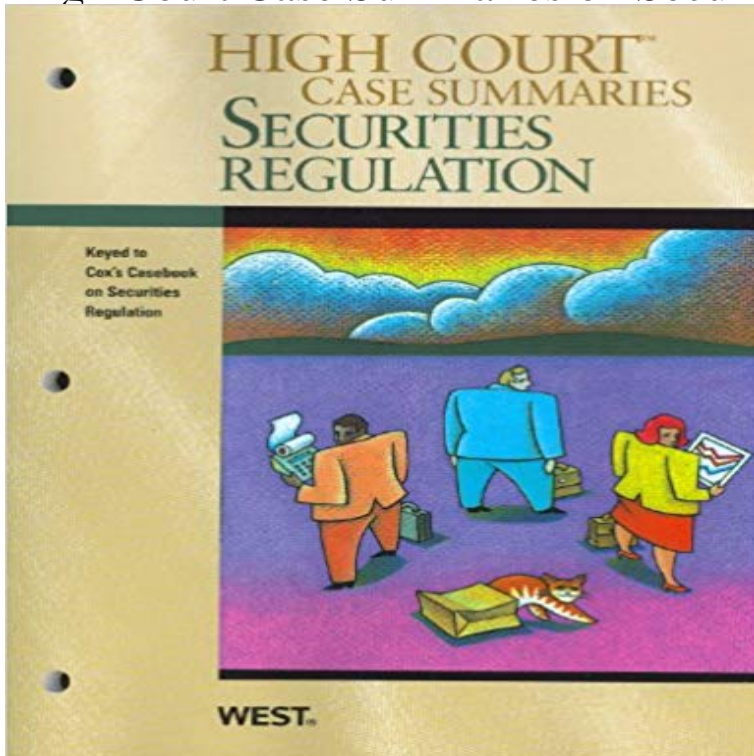


High Court Case Summaries on Securities Regulation, Keyed to Cox, 6th
