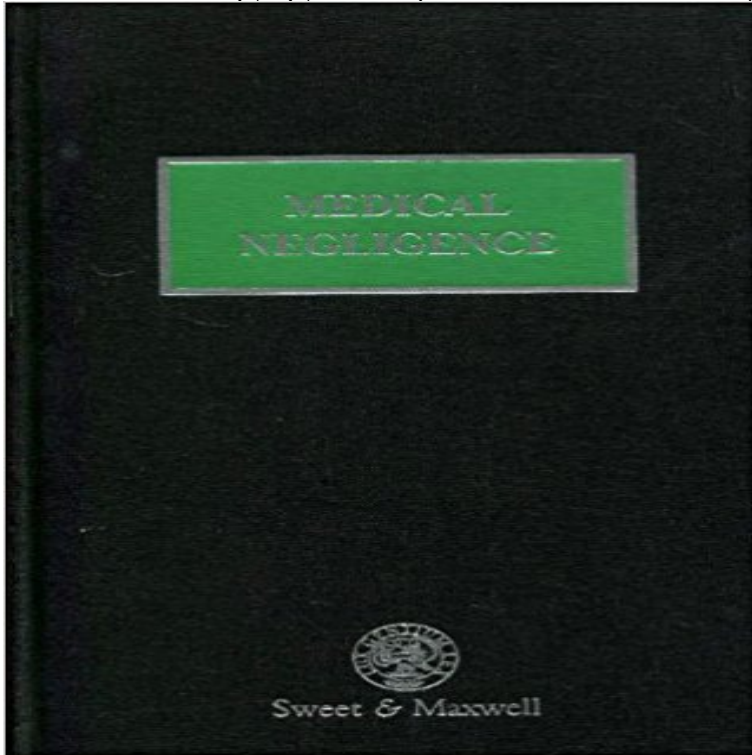


Medical Negligence (Tort Law Library)
