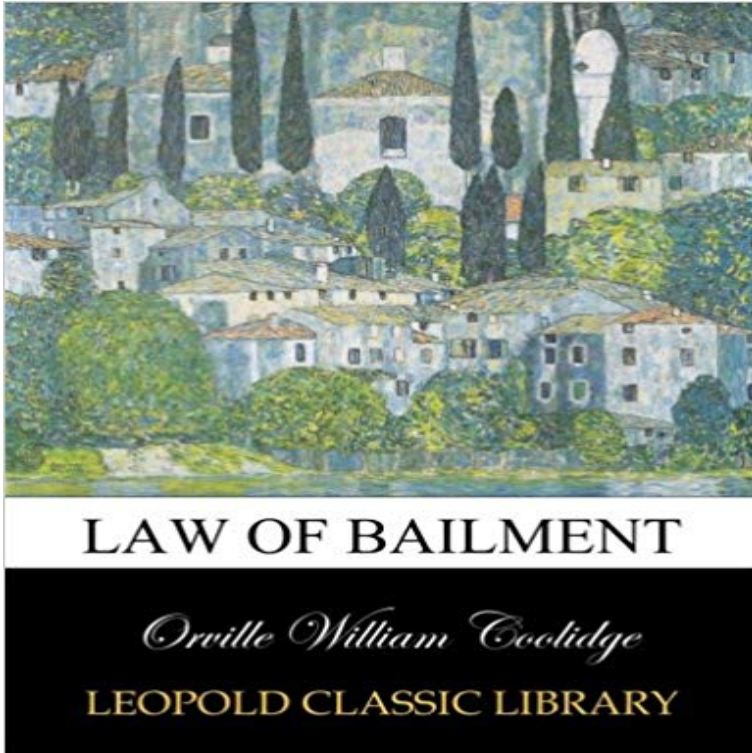


## Law of bailment
