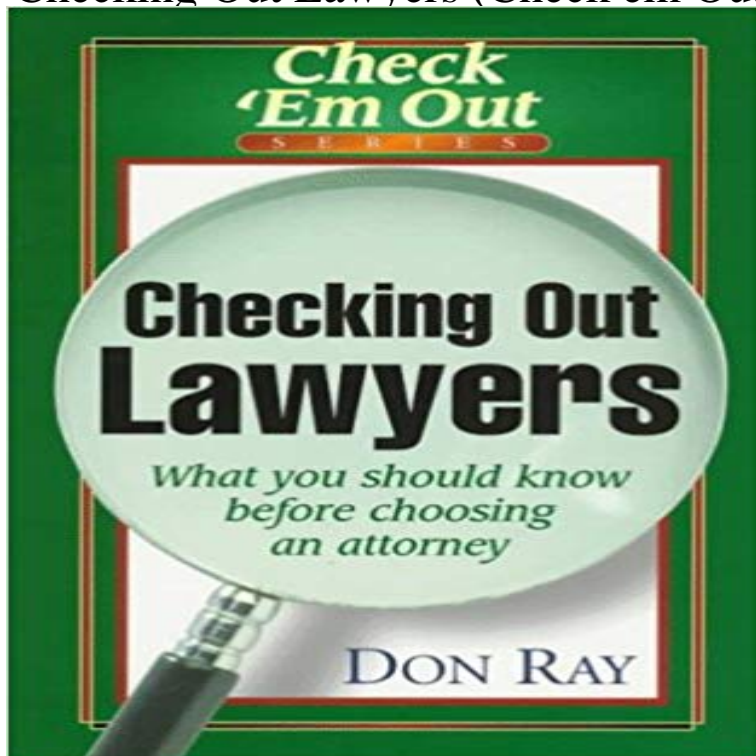


Checking Out Lawyers (Check em Out Series)
