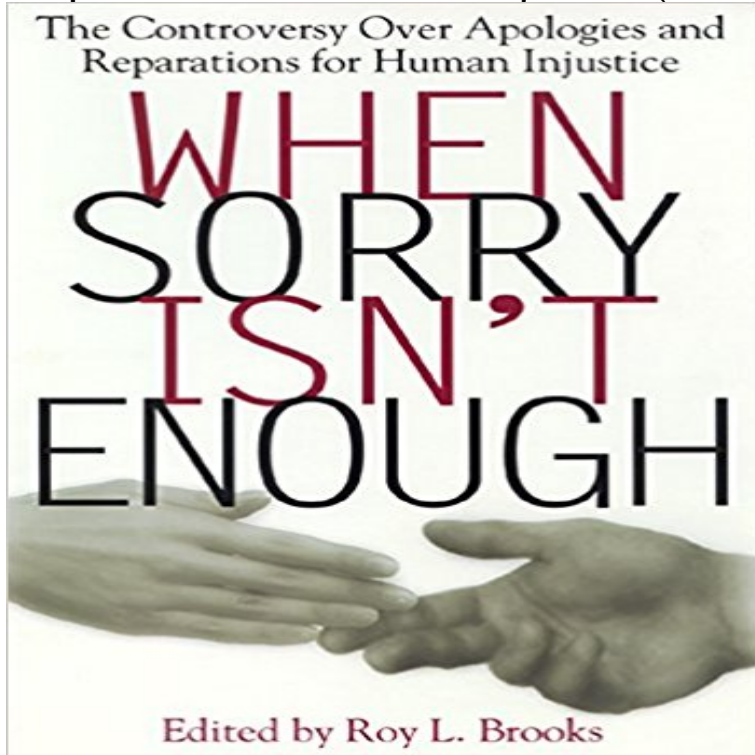


## When Sorry Isn't Enough: The Controversy Over Apologies and Reparations for Human Injustice (Critical America)
