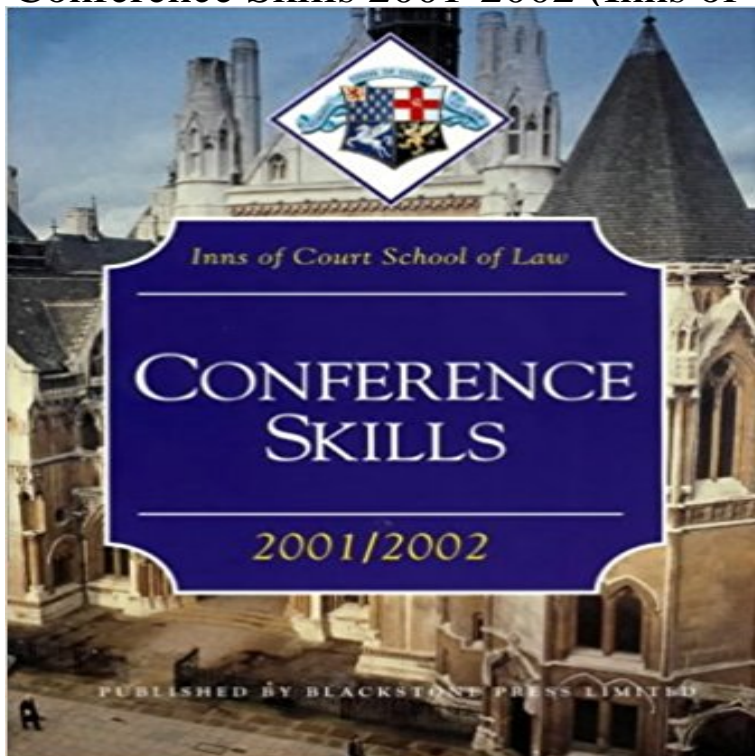


## Conference Skills 2001-2002 (Inns of Court Bar Manuals)
