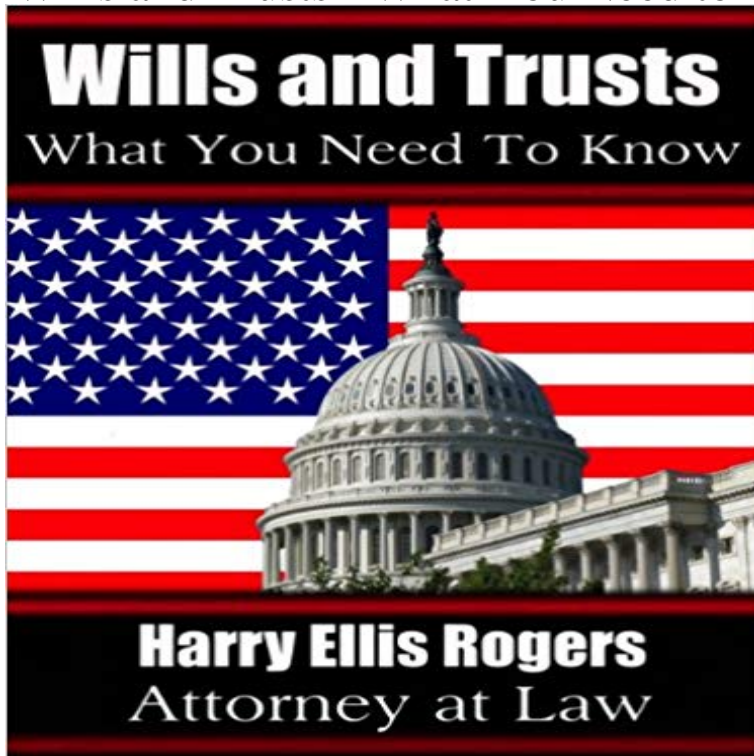


Wills and Trusts - What You Need to Know
