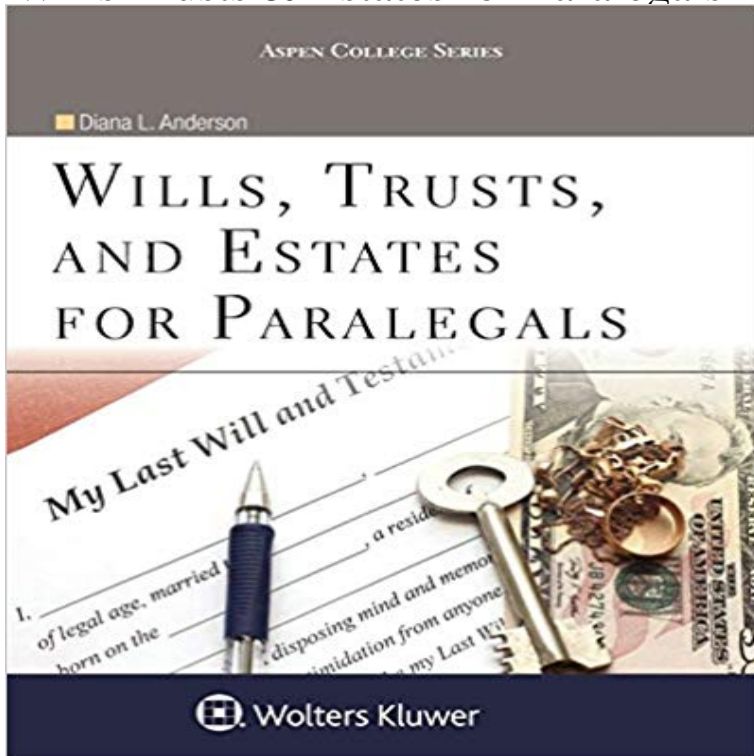


Wills Trusts & Estates for Paralegals
