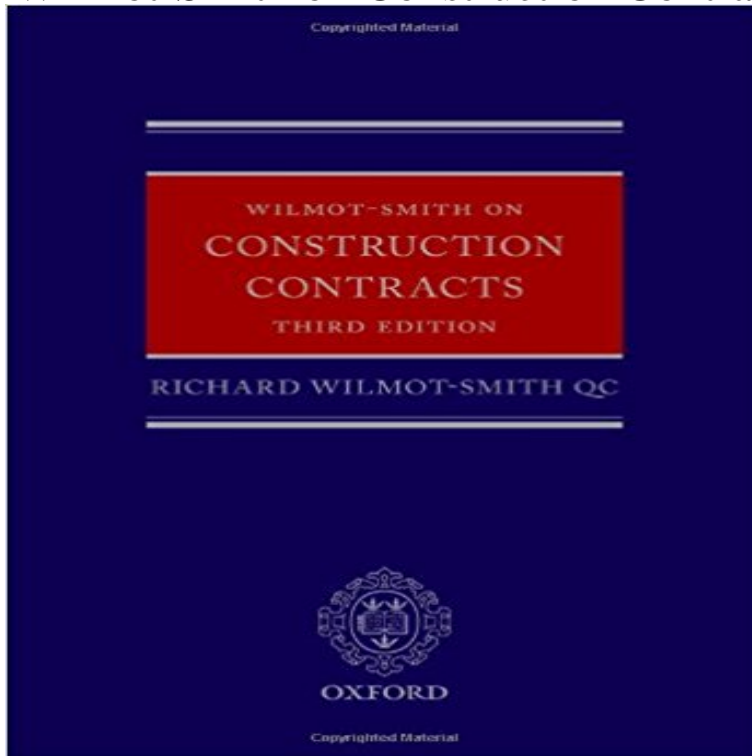


# Wilmot-Smith on Construction Contracts
