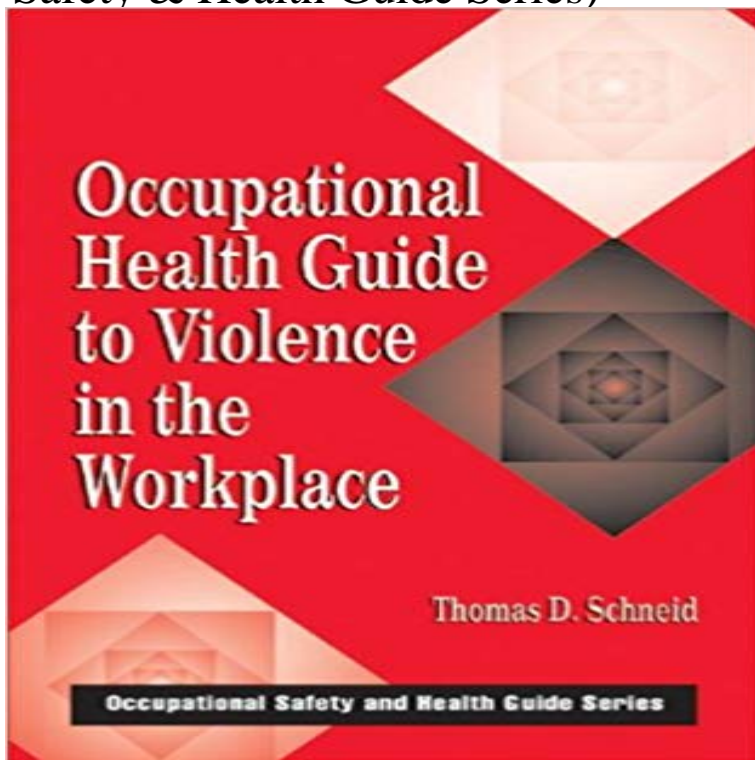


## Occupational Health Guide to Violence in the Workplace (Occupational Safety & Health Guide Series)
