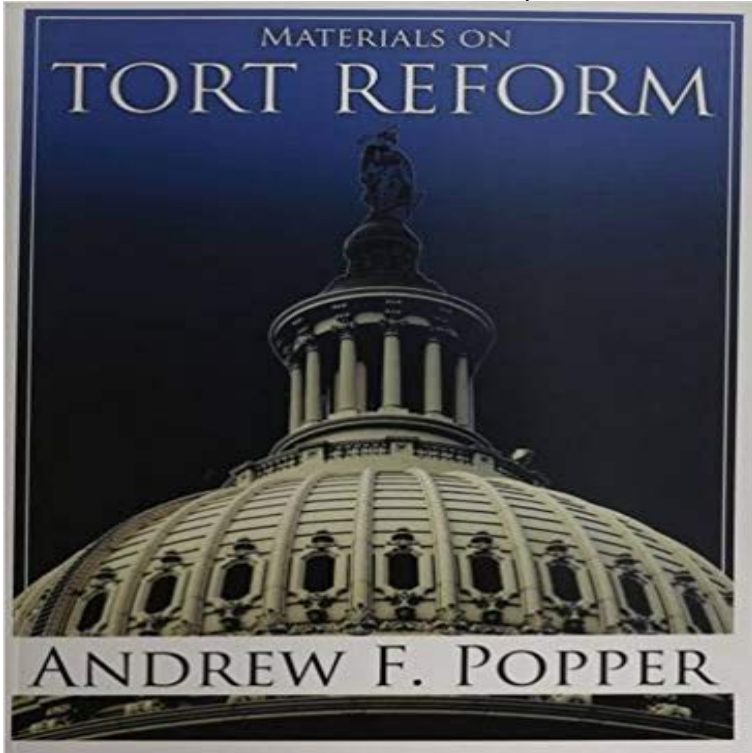


## Materials on Tort Reform (American Casebook Series)
