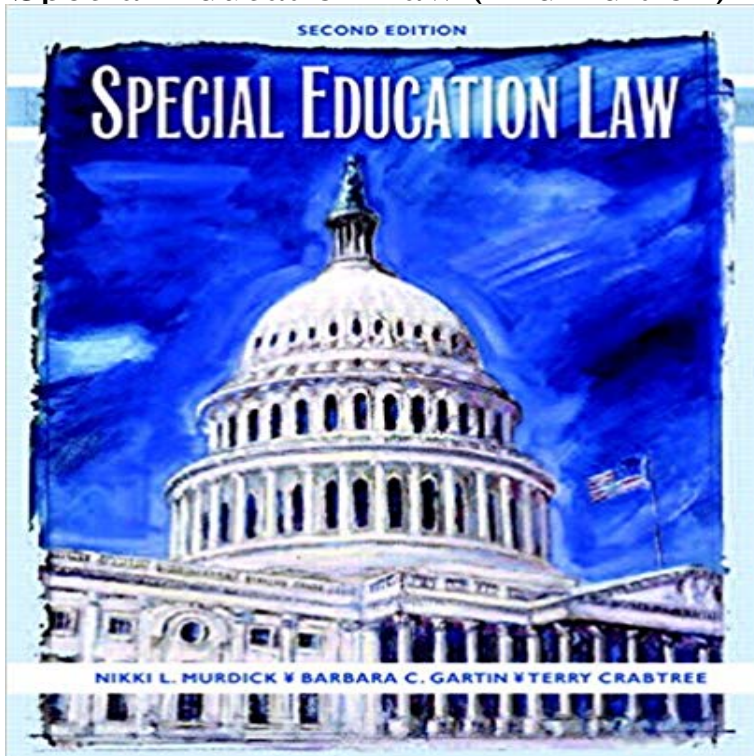


## Special Education Law (2nd Edition)
