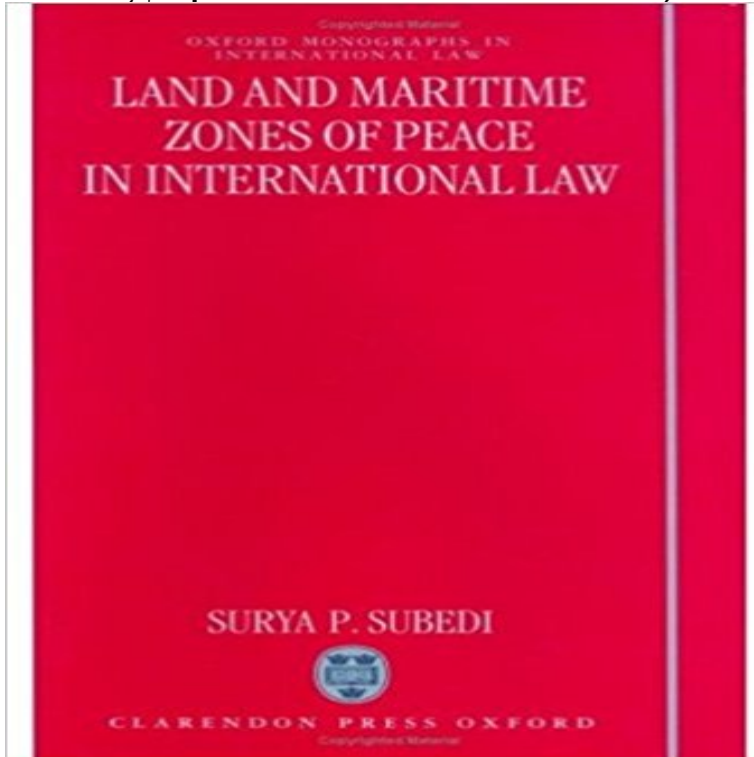


# Land and Maritime Zones of Peace in International Law (Oxford Monographs in International Law)
